

Additional Cash Handout to Supplement Tax Cut Benefit

- Iwakuni city is to provide additional cash handout in increments of ¥10,000 for those who could not fully benefit from the Fixed-Amount Tax Reduction program.
- There are cases where a recipient needs to send an application form. Please see the payment procedure on the back.

Eligibility and Amount paid

Cash Handout Type1

Eligibility Requirement:

A difference between the actual amount of benefit to be paid based on the adjustment calculation made this year and the benefit paid through the previous year's tax reduction adjustment payment program occurred after both the total income tax for the period of January to December 2024 and the tax reduction amount were confirmed.

Amount paid to the recipient:

 the actual amount of benefit to be paid based on the adjustment calculation made this year – the benefit paid through the previous year's tax reduction adjustment payment program

[Benefit Amount Calculation] The sum of (1) and (2) rounded up in increments of ¥10,000

- (1)Income tax reduction amount Estimate total income tax from Jan to Dec 2024/Reiwa 6 (calculated the previous year) or Actual total income tax from Jan to Dec 2024/Reiwa 6 (calculated this year)
- (2)Resident tax reduction amount Resident tax calculated based on total income from Jan to Dec 2023/Reiwa 5

Cash Handout Type2

Eligibility Requirement: The conditions 1 to 3 listed below are fulfilled.

- ①The tax amount of the two shown below before the tax reduction program are 0 yen.
 - Actual total income tax from Jan to Dec 2024/Reiwa 6
 - Resident tax calculated based on income amount from Jan to Dec 2023/Reiwa 5
- ②You file a blue or white tax return, or the total income is over ¥480,000.
- ③You are not the head of the family nor a member of the family eligible for the low-income household benefit*
 - *The benefit provided for households exempted from FY2023/Reiwa 5 resident tax or the one provided for households that qualified for FY2024/Reiwa 6 resident tax exemption

Amount paid to the recipient:

¥40,000 in principal (¥30,000 if living abroad as of January 1 2024)

Type 1 Eligible Recipient with a bank account registered with the city

NO NEED TO RETURN documents if no changes to your personal information

If there are any changes to the information (your bank account, acceptance or rejection of the benefit, tax amount, etc.) on the application form sent from the city, return or submit the enclosed forms after updating it.

Deadline: Friday, August 15,2025 (Reiwa7)

Type 2 Eligible Recipient

Recipient without a bank account registered with the city

NEED TO RETURN documents or SUBMIT an application form

Either return the enclosed forms after filling out or submit them in person at the benefit application section.

Deadline: Friday,October 31,2025(Reiwa7)

Payment Procedures

1 Recipient whose bank account is already registered with the city

- The "application form" which includes the payment details or personal information will be sent to eligible benefit recipients. The benefit will be transferred to the bank account registered for receiving public money or the one registered for FY 2024 (Reiwa 6) Tax Cut Benefit Program. There is no need to submit if there are no changes to your bank account or payment details written on the form.
- If there are any changes to your bank account, acceptance or rejection of the benefit, tax amount, etc., please fill out the forms with the required information and return them with necessary documents in the enclosed return envelope or submit them in person at the benefit application section.

Deadline: Friday, August 15, 2025 (Reiwa 7)

*No need to submit if there are no changes.

2 Recipient whose bank account is not registered with the city or Type 2 eligible recipient

The "confirmation form" which includes the payment details or personal information will be sent to eligible benefit recipients. Please fill out the forms with the required information and return them with necessary documents in the enclosed return envelope or submit them in person at the benefit application section.

Deadline: Friday, October 31, 2025 (Reiwa 7)

*The forms must be submitted NO LATER THAN the above date.

- 3 Those who need to apply for the benefit (if you do not receive neither the application form nor the confirmation form and meet the benefit application requirements)
 - Application may be necessary if you moved to Iwakuni City after January 2, 2024 (Reiwa 6).
 Please check whether if you meet the application requirements.
 - Please visit the benefit application section at the city hall if you don't receive the application form or the confirmation form by August 20, 2025 (Reiwa 7) and meet the application requirements.

Deadline: Friday, October 31, 2025 (Reiwa 7)

*The forms must be submitted NO LATER THAN the above date.
